#### 3. Treasurer's Report

Although there was no meeting in January GW contacted the committee to explain that he proposed contributing £300 towards the training facilities which would leave around £150 in addition to the small deposit account of £250. The proposal met with approval and the payment was made. Obviously at present with no matchday income any means of raising additional funds is very limited.

For the past month the Virtual 50/50 draw has raised £156.59. In addition, there were membership subs of £11.56 and a German fan purchased Club merchandise using our Pay Pal account, the total for which was £105.48.

Our only expenditure during the month was our normal £10 towards the Pledge.
